- 1. What are some of the emotions women express after having an abortion, both within days and years afterwards? Do women who receive an abortion feel that their decision was the right one for them?
- 2. The Turnaway Study shows that post-abortion emotions vary from woman to woman, largely as a function of life circumstances, difficulty with decision-making about their pregnancy, and experiences of stigma and social support. What are some aspects and conditions of your community that might affect a woman's emotions about her abortion, both immediately and years later?

What are the advantages and disadvantages to asking in this way? If you were designing the study, what other questions would you ask to measure participants' long-term goals?
- 2. The researchers found that individuals who received their wanted abortion were more likely to have positive life plans. Why do you think they found this? What factors may have influenced their visions for the future?
